The 2024-2025 Mater Christi School Annual Fund

Dear Mater Christi School family:

We were happy to host a community event this fall entitled **OUR MCS**. The evening included a comprehensive look at our school in the aftermath of what I described as “the dust having settled.” The “dust” in this case represents the momentous acquisition of our property two years ago at 50 and 100 Mansfield Avenue, and the planning required as we envision MCS under our own ownership and direction. The dust is still settling, but the vision is coming into focus and plans are underway.

The “dust settling” process included a key question that we asked ourselves in the midst of the property acquisition: **WHAT DO WE DO BEST?** Our response came quickly: **We first meet students at a young age and bring them up through the holistic Mater Christi experience of education and formation.** Our upward trajectory as a school over the past seven years has been a testimony to that response, as we have nearly doubled our enrollment in grades K-4 during that time period.

“Dust settling” also unveils a new vision for our facility. We are currently in the process of building a new Early Education, Music, and Band Center along the wooded border at the back of our property. This ~\$3 million project is being funded by the generosity of anchor partners who love our school and want to see it flourish for decades to come. We currently do not have space for all of our Preschool and Pre-Kindergarten classrooms or to split our 3rd grade cohort into two sections, and this project will provide the necessary space for both. The center will also include a beautiful facility for our music and band programs, each of which are currently in temporary spaces in the former convent. We plan to welcome students into our new Early Education, Music, and Band Center during the 2025-2026 school year.

In addition to this capital project, we are also planning to give our middle school building a “facelift” with upgraded lighting, flooring and carpeting. Unlike the Early Education, Music, and Band Center capital project, these facility upgrades are funded entirely from our regular operating account, and by extension, out of our annual fund.

WHAT IS "THE GAP"?

\$15,307* Cost per pupil at MCS

– \$13,886 MCS tuition (6th-8th)

\$1,421 "The Gap" per pupil

*\$27,537 is the cost per pupil at K-12 Vermont Public Schools (K-12) (Source: Vermont Agency of Education, August 2024)

At the **OUR MCS** event, I explained "the gap" between the cost to educate each student and the price of tuition. The simple equation **COST – TUITION = GAP** reveals a shortfall of **\$1,421 PER STUDENT**. We fill that gap, and therefore balance our budget, each year in large part through our annual fund, which represents **8%** of this year's budget. Gifts to our annual fund are used entirely for the daily operation of our school, including teachers' salaries and maintenance of our facility. Annual fund dollars do not support capital expenditures. Our annual fund makes all our programs possible, and **meeting our annual fund goals as a community means meeting our goals as a school.**
